## ORDINANCE NO. 579

AN ORDINANCE REGULATING THE OPEN BURNING OF RESIDENTIAL YARD WASTE CONSISTING OF LEAVES AND BRUSH FROM VEGETATION GROWN ON A RESIDENTIAL PROPERTY.

NOW THEREFORE BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ALMA, MISSOURI AS FOLLOWING USER CHANGE SYSTEM IS ESTABLISHED.

Section 1.       **Burning Limited**

- A. Within the corporate limits of the City of Alma, the open burning of residential yard waste consisting of leaves and brush from vegetation grown on a residential property is permitted.
- B. The burning of garbage, tires, fabric, furniture and other kinds of waste is prohibited.

Section 2.       **Restrictions on Burning Yard Waste**

The burning of yard waste shall be conducted as follows:

- A. All fires must be at least 20 feet away from any building or structure.
- B. All fires shall be monitored from a point on the property where the fire is located by a person capable of containing a fire, should containment be necessary. A child twelve (12) and under is not considered a person considered capable of containing a fire.
- C. If the safety of the community or the public may be endangered, the Mayor, Fire Department Officers or Police Department may invoke a temporary burning ban.
- D. If climatological conditions indicate open burning may create a health hazard, the mayor, Fire Department Officers or Police Department may invoke a temporary burning ban.
- E. All Fires shall be completely extinguished by 8:00 P.M.
- F. Any person engaged in open burning in violation of this ordinance shall be summoned for a misdemeanor violation.

Section 3.       Any person or persons not complying with the rules as stated above shall be considered to have committed the offense, which upon conviction thereof, shall be punished by a fine of not more than one thousand dollars (\$1,000.00), and/or cost of clean up that meet all state and federal requirements, and/or by imprisonment for not more than ninety (90) days.

This ordinance shall take effect and be in force from the after its date passage and approval.
